I owe you an apology for endorsing Byron Katie on my website under the Recommended Reading section. When I read her books, *Loving What Is*, and *I Need Your Love, Is That True?* I believed wholeheartedly that they were written by a person who was non-violent. I found a great amount of truth in those books. Furthermore, I believed that Byron Katie was an enlightened person who authored her books from her own spiritual wisdom, and did not gain the vibrational content found within her books from any persons outside of herself. I would not have recommended Byron Katie's books to anyone if I had known that she was a violent person who had tortured, abused, raped, and murdered hundreds of people in this lifetime. I would not have publicly acknowledged her as one of my spiritual teachers as a result of gaining so much insight from the books she published if I had known the work was not her own.

This week I discovered that Byron Katie abused my trust in her basic human decency, and abused the trust of many, many of her readers and workshop students. I encourage and support anyone who has been raped by Byron Katie to file a police report and press charges. I apologize for not realizing it sooner that this woman is unsafe to be around. I apologize for endorsing her as a teacher on my website. It is my vote that Byron Katie be prosecuted through the Department of Justice and sent to death row; her crimes are worthy of being punished with the death penalty.

BRYON KATIE

Born 1956 a female homosexual

Mental Disorders as defined by the diagnostic criteria of the DSM-5:

Byron Katie has had Anti-Social Personality Disorder from 1958-2018

Pedophilic Disorder 1963-2018

Sexual Sadism Disorder 1963-2018

Mental Disorders as defined by the diagnostic criteria of the DSM-2:

Psychopathy 1971-2018

Byron Katie committed her first murder at age 10 with a knife. She was a victim of trauma-based mind control. The first murder that Byron Katie committed with her free-will choice was on August 17, 1971.

The CIA ordered Byron Katie to assassinate a German citizen who was protesting the United States involvement in war; the CIA ordered Byron Katie to torture her victim and give her the slowest painful death possible in order to promote terrorism. The CIA did not order Byron Katie to rape her victim first, but she did. On August 17, 1971 in Frankfurt, Germany, Byron Katie lured a 26 year old homosexual female human rights activist into bed. Byron Katie raped this woman at 4:23pm, and the rape ended at 5:12pm, when she began beating her victim to death. Byron Katie wore gloves and beat this woman to death with her hands, and only her hands. Her victim died from torture at 6:25pm. Byron Katie was trained to kill by the CIA. She could have killed this woman in less than two minutes if she wanted to, but she was ordered to torture her victim to death. Both Byron Katie and her victim were sober when this rape and murder took place. The name of the woman that Byron Katie raped and murdered on August 17, 1971 was Dahosjo Boeddmpoy. She was born on September 11, 1945 in Seiffen, Germany.

Byron Katie was a full-time employee of the CIA from 1971-1991. She was suspended from work with the CIA 34 times for compulsive lying and for raping her co-workers; all of the incidences of rape which earned her suspension from work with the CIA during this period of time were crimes committed on heterosexual females.

Byron Katie was a full-time employee of the NSA from 1992-2000. In the year 2000, she was suspended from work with the NSA for a two year period when they discovered she had raped 187 heterosexual female co-workers during her employment with the NSA.

From 2007-2018, Byron Katie was employed by the CIA on and off; she received 84 suspensions from work that lasted a minimum of 2 weeks and a maximum of 6 months. All 84 suspensions were based on raping co-workers and compulsive lying; all 84 suspensions for rape involved homosexual victims only.

Byron Katie worked for the NSA from 2003-2007. In 2007, she was suspended from work with the NSA for one full year. She returned to work for the NSA in 2008, and has continued to work for the NSA on and off through 2018. From 2008-2018, Byron Katie was suspended from work with the NSA 8 times for raping co-workers; 7 suspensions were six week periods, and 1 suspension lasted a full year.

Between the years 1971-2018, Byron Katie committed felony rape on 278 people, all female. Over 75% of the times that Byron Kate has raped, she used GHP to drug her victims and erase their memories. Byron Katie's youngest rape victim was 24 years old, and her oldest rape victim was 88 years old. About 26-27% of Byron Katie's rape victims have been homosexual.

Over 50% of the women who survived sexual assault from Byron Katie during the years 1971-2018 were less than 27 years old.

Over 45% of the 278 women that Byron Katie raped during the years 1971-2018 were more than 77 years old.

Between 1971-2018, Byron Katie committed felony rape as defined by the federal laws of the U.S. government 358 times. Over 50% of these rapes took place between 1971-1990.

During the years 1971-2018, Byron Katie has committed felony murder as defined by the federal laws of the U.S. government 566 times. More than 95% of her murder victims were female.

Over 50% of the people who Byron Katie murdered during the years 1971-2018 were less than 27 years old. She has only murdered a co-worker at the request of her employers.

Over 50% of the murders that Byron Katie committed took place between 1971-1994.

The FBI, NSA, and CIA all provide GHP to their employees for the purpose of promoting rape. Each time Byron Katie was suspended for raping her co-workers, the suspensions were not punitive; she had been caught raping on her assignments and this required that she be relocated.

The federal laws of the United States government require that Byron Katie be prosecuted for international terrorism. Byron Katie's crimes qualify her for capital punishment.
