

SENATOR RON WYDEN

Ron Wyden has committed conspiracy to commit murder as defined by the federal laws of the U.S. government more than 478 times in this lifetime.

In this lifetime, Ron Wyden has broken the federal laws of the U.S. government against domestic terrorism as defined by United States Code Title 18 Chapter 113B and the federal laws of the U.S. government against stalking as defined by United States Code Title 18 Chapter 110A Section 2261A and the felony crime of invasion of personal privacy in the first degree according to Oregon Revised Statutes 163.701 more than 36,000 times.

In the year 2018, Ron Wyden committed the felony crime of invasion of personal privacy in the first degree according to Oregon Revised Statutes 163.701 more than 13,000 times; every time he committed this crime upon any U.S. resident in 2018 he concurrently broke the federal laws of the U.S. government against domestic terrorism as defined by United States Code Title 18 Chapter 113B and the federal laws of the U.S. government against stalking as defined by United States Code Title 18 Chapter 110A Section 2261A.

During the time frame of 1/1/2012 to 4/25/18:

Ron Wyden committed rape in the first degree as defined by ORS 163.375 more than 2,600 times, with 684 of those crimes taking place in 2018 within the context of human trafficking.

During the time frame of 1/1/2018 to 4/25/18:

Ron Wyden committed sodomy in the first degree as defined by ORS 163.405 a total of 682 times.

Ron Wyden committed sodomy in the third degree as defined by ORS 163.385 a total of 684 times.

Ron Wyden committed criminal conspiracy as defined by ORS 161.450 at least 734 times.

SENATOR JEFF MERKLEY

Jeff Merkley has committed over 779 felonies as defined by the federal laws of the U.S. government in the year 2018.

On February 17, 2018 between 5pm and 8pm, Jeff Merkley committed predatory sexual assault against a child as defined by NY Penal Code 130.96. The child he raped was a 4 year old boy with permanent residence in the state of New York. Jeff Merkley committed predatory sexual assault against a child as defined by NY Penal Code 130.96 upon the same child on February 19th, 2018 between 9am-12pm, and on February 22nd, 2018 between 9am-2pm.

On March 7, 2018 between 9am-3pm Jeff Merkley committed predatory sexual assault against a child as defined by NY Penal Code 130.96. The child he raped was an 8 year old girl with permanent residence in the state of New York. On March 13, 2018 between 6pm-11pm Jeff Merkley committed predatory

sexual assault against a child as defined by NY Penal Code 130.96 on the same girl. These crimes took place in New York City.

PREVIOUS PORTLAND MAYOR CHARLIE HALES

During the time frame of 1/1/2012 to 12/31/2017:

Charlie Hales committed unlawful sexual penetration in the first degree according to Oregon Revised Statutes 163.411 a total of 1,387 times between the years 2012-2017.

The youngest age of any person Charlie Hales committed unlawful sexual penetration in the first degree upon according to Oregon Revised Statutes 163.411 between the years 2012-2017 was 4-5 years old.

Charlie Hales committed rape in the first degree according to Oregon Revised Statutes 163.375 a total of 2,869 times between the years 2012-2017.

The youngest of any person Charlie Hales committed rape in the first degree according to Oregon Revised Statutes 163.375 upon between the years 2012-2017 was 3 years old; the youngest of any girl whose vagina he penetrated with his penis between the years 2012-2017 was 7 years old.

PORTLAND MAYOR TED WHEELER

During the time frame of 1/1/2012 to 12/31/2017:

Ted Wheeler has committed more than 2,700 felonies as defined by Oregon Revised Statutes between the years 2012-2017.

Ted Wheeler committed unlawful sexual penetration in the first degree as defined by Oregon Revised Statutes 163.411 on more than 4,000 different people under the age of 16 years old between the years 2012-2017.

Ted Wheeler committed unlawful sexual penetration in the first degree as defined by Oregon Revised Statutes 163.411 upon more than 3,700 males aged 13-14 years old between the years 2012-2017.

Ted Wheeler committed rape in the first degree as defined by Oregon Revised Statutes 163.375 on more than 3,500 males aged 13-14 years old between the years 2012-2017.

Ted Wheeler committed rape in the first degree as defined by Oregon Revised Statutes 163.375 on more than 2,600 males under the age of 16 years old between the years 2012-2015.

No, a 13 year old boy did not lie about his age to Ted Wheeler in an act of volunteering himself for sex and Ted did not mistake him for someone older.
