

THE ROLE OF THE CIA IN SHAPING A TRAUMA-BASED MIND CONTROL PROGRAM OF PRIVACY VIOLATIONS

It is the FBI, CIA, NSA, DOJ, Secret Service, and every other branch of federal law enforcement that uses decades of research on trauma-based mind control to promote a regime of terrorism that enables a preposterous level of violent social norms eroding our society's definition of mental health.

First of all, at what point did the CIA begin to get away with openly rejecting their responsibility to uphold and enforce the federal laws of the United States government?

The CIA has publicly announced on their website that their scope of duty has nothing to do with law enforcement and is limited to spying for corporate interests. People sick with the mental illness of voyeurism (it is classified as a mental illness in the Diagnostic and Statistical Manual of Mental Disorders) who want to be paid to spy on people and abuse trust by going undercover and fooling people into believing they are a lover they can confide in are given a career working for the CIA that is glorified as a service of responsibility to the security of this nation, when in reality it is a line of work where pedophiles go to experience legal immunity for rape and torture.

The press publishes stories to make CIA agents seem like they are humane, when in fact this is a group of people who watch videotapes of people surviving torture-based interrogation for their sick entertainment, including a version of water-boarding based on oral rape for 4-6 minutes of asphyxiation approaching the time in which lack of oxygen to the brain causes death. That story in the newspapers about CIA agents almost crying from victimization of witnessing the level of brutality in torture-based interrogation authorized by the recently nominated director was a complete lie; every CIA agent would masturbate to such a scene of torture, not gasp with horror or cry over it, this is why they made spying, murder, torture, rape, surveillance, and trauma-based mind control their career.

Spying is objectifying and inherently violent.

Violence is a game only to a pedophile.

Spy games are pedophile games.

The press is an international network of sharing news that is manipulated by the CIA for the purpose of shaping a regime that will promote and glorify their lifestyle of sick violence. Within the last five years, American society has increased tolerance of everyday crimes of voyeurism to such a degree that misdemeanor harassment and felony invasion of personal privacy have become an everyday occurrence at work and at school, where CIA agents go undercover to promote voyeurism.

The laws around invasion of personal privacy vary from state to state; some states delineate that a person must be nude or the privacy of their genitals violated for this law to be broken, and some states outlaw taking a picture of a person out in public when they have a reasonable expectation of privacy. When the press publishes stories over and over and over again of celebrities being stalked by predators with cameras and these people who have the wealth to pay a law firm to defend their civil rights do

nothing, the population of this country is convinced that nothing illegal has been done. Because the press sets a repeated example of people getting away with activities that are not talked about as illegal, it sends a message out to the public that no laws have been broken.

Did you know that if you walked up to a stranger standing in a public courtyard square and took a photograph of them without their permission in which they could be identified and published it on Facebook, you would have committed a felony crime in several states of this country? Teenagers are harassing their classmates at high school by taking photographs of them with their cell phones and publishing them on Instagram to mock them.

The people of this country seem to believe that legal boundaries around personal privacy do not exist because they are completely ignored by the press, which has been a deliberate program of social conditioning planned by the people addicted to voyeurism to normalize their violence.

Students of all ages are supposed to be able to attend our public schools in safety. "Yes, but, bullying has been around for centuries, and bullying at school is a tough part of life young students sometimes have to deal with and learn how to stand up to." Okay, but that was before CIA agents recruited at age 15 and trained in promoting rape began going undercover at age 20-22 in American high schools when they still look young enough to pass for 17 years old and started selling date rape drugs to their classmates, and perpetrating statutory rape on virgins fresh out of 8th grade.

Don't forget the fake high school students giving speeches at the March for Our Lives rallies about school lockdowns and gun control. Sure, a bunch of socially responsible teenagers are going to take over where fully grown adults have lapsed and lead a national movement for gun control; really??? Does this help you make friends, or does it make it more difficult as people form opinions about you based on celebrity gossip? Can you ever go to a movie theatre like a regular person ever again, or do you constantly have to have a bodyguard with you when you go out in public?

If you go through a breakup and your ex wants revenge, are the embarrassing details of your personal life going to show up in the National Inquirer unless you pay the extortion fee of hundreds of thousands of dollars to keep them silent? Can you ever go skinny-dipping in the ocean ever again, or will you be looking over your shoulder for the rest of your life afraid of the predator stalker looking to make thousands of dollars with one good photograph? It is not an expression of health to adapt to harassment by sacrificing boundaries and suppressing your true desires for privacy.

How is it that our American society can embrace the tabloids publishing photographs of celebrities in their swimsuits attempting to enjoy the beach making an announcement about how they gained weight? Doesn't anyone find that to be sick and violent and wrong? It is harassment towards people who were empowered enough to earn a high income as artistic performers. Is this how we treat the artists who gave so much of themselves, who shared themselves for our happiness and amusement?

It is nothing short of a hate crime, yet it is tolerated as totally normal and acceptable. To me, viewing the tabloids featuring photographs of female celebrities taken without their consent, violently taken against their will in an act of predatory stalking, and published to the public to shame them for gaining weight is a hate crime just as much as leaving a noose in the African-American exhibit of the Smithsonian Museum. There is no outcry for this bullying, no offense taken, because it is the press who regularly promotes these hate crimes and abdicates responsibility for how they have influenced and shaped a lifestyle of violence towards women.
