

LETTER TO THE AMERICAN PSYCHIATRIC ASSOCIATION

August 27, 2018

Dear American Psychiatric Association:

The current version of the Diagnostic and Statistical Manual of mental disorders is in need of a major remodel to remove support for domestic terrorism through systematized sexual violence. The DSM-5 is frequently used in the court of law for criminal cases, child custody battles, and civil lawsuits to attack the credibility of victims of sexual violence instead of to re-direct the criminally insane to the proper channels of intervention and containment.

I question the priorities of the clinicians who have filled the pages of the DSM-5 with a total of 10 personality disorders, and yet there is not one page dedicated to explaining the mental disorder that drives people to put human feces upon children or adults they are sexually abusing. The police are quite familiar with the frequency of violent sex offenders using feces in the child pornography they create in order to induce the gag reflex in the sexual molestation victim.

The confusion and lack of discernment generated by classifying sexual violence as a sexual deviation instead of one facet of the expression of violence coming from affected individuals serves to promote ignorance on the root of the pathology.

Rape is not a kink. Pedophilia is not a kink. Stomach torture is not a kink. Sexual violence is not a sexual orientation; it is one expression of a larger imbalance and pathology.

Every person who has Pedophilic Disorder also concurrently has Sexual Sadism Disorder; this is because Pedophilic Disorder is a variation of Sexual Sadism Disorder in which the focus is more upon children. With both Sexual Sadism Disorder and Pedophilic Disorder the urges for destruction, degradation, waste, harm and damage to others is the primary pattern of imbalance with it being expressed through many other outlets aside from their sexual activities. There is a very high rate of co-morbidity between people with Sexual Sadism Disorder and Anti-Social Personality Disorder.

Being that the Diagnostic and Statistical Manual of mental disorders is used by lawyers almost as much as it is used by psychologists and psychiatrists to set precedencies that form our social policies, those responsible for publicizing the system of clinical diagnosis are liable for a class action civil lawsuit for the harm and damage caused by the neglect to identify behavioral patterns of violence in people with Sexual Sadism Disorder and Pedophilic Disorder.

By promoting the lie that not every person who has pedophilia acts on their impulses and urges to participate in sexual violence towards children, the public is misinformed and a safety hazard has been created. Every adult in the United States who suffers from pedophilia in 2018 has broken a state law against felony child sexual abuse (includes possession of child pornography) in this lifetime. Pedophiles are not a group of sexually repressed people living in deep guilt and shame about their deviation; pedophiles frequently commit violent crime such as murder, theft, poisoning, assault, and extortion.

61% of all people living with pedophilia have committed attempted murder or murder in this lifetime.

There are 6,743,669 people who currently have permanent residence in the United States that have raped a person while they were dying in this lifetime; 83% of them have served in the U.S. military in this lifetime. The DSM-6 needs to have a full page dedicated to classifying this mental disorder so that treatment protocols can be researched and sexual violence in the military can be addressed.

It is not necessary for the national security of this country to authorize billions of dollars to be spent supporting the military so that violent sex offenders can be given more opportunity to rape people almost dead.

In the year 2018, there are more than 21 million people worldwide surviving human trafficking in the context of sexual slavery. More than 121,966,000 people have participated in human trafficking as customers, traders, or traffickers in the context of sexual slavery in 2018.

Out of all the doctors licensed to practice urology in 2018 by a state medical board in the U.S. and who have performed a circumcision procedure this year, 83% have committed felony possession of child pornography in 2018, and 67% have broken state laws against child molestation by sexually abusing a child with direct contact in 2018. Circumcision before the age of consent is male genital mutilation.

The DSM-6 would serve the human race well with a section classifying the genital mutilation of infants, children, or adults as a paraphilic mental disorder, to support the liberation of parents to question the authority of doctors who recommend circumcision for their male newborns.
