

THE 21 MILLION DOLLAR LIE

Emily Doe was not raped by Brock Turner.

Someone else was raped by Brock Turner. In this lifetime, Brock Turner has committed felony rape, felony child molestation, and felony predatory assault against a child.

Emily Doe was a secret employee of the Obama Administration in the years 2008-2016. She misled the public about being raped by Brock Turner as a part of a political game.

It is against the statutes of the press to ever publish a story about sexual violence done to an adult or a child, not even anonymously, without the consent of the victim or the victim's guardians. This led to international diplomacy in which several different countries got involved in another bet. The governments of the United States, Japan, France, England, Netherlands, Russia, Italy, Greece, and Poland all got involved in making a new bet that had to do with press coverage, and this bet was illegal. California Penal Code 214 was broken when this international wager took place, and many other laws were broken as well.

The governments of the United States, Japan, France, England, Netherlands, Russia, Italy, Greece, and Poland were all engaged in a bet during 2015 that was a competition over which country could rape the highest percentage of their country's virgins aged 0-16 in one year's time. The United States won the wager, with the highest percentage of their country's population of virgins under the age of 16 being raped. 758,282 permanent residents of the United States who were virgins under the age of 16 years old were raped during the year 2015.

The prize for winning this wager was that a story about a high profile figure date raping and getting away with a slap on the wrist would be published around the world as an advertisement for human trafficking in the country that won the bet. The reward for winning the bet meant free advertising world-wide in the public press guaranteed to increase trafficking sales.

The governments of the United States, Japan, France, England, Netherlands, Russia, Italy, Greece, and Poland have participated in this international wager from 1989-2018. 1989 was the first year that the government of the United States entered into an international competition over how many of their country's population of virgins under the age of 16 years old they could rape in one year.
